# The Effectiveness of Group Guidance Service Implementation in Improving the Comprehension of Advanced Study For Student of Ninth Graders at Junior High School of Darul Hamidin Pademara

Abstract. This study aims to know the effectiveness of group guidance service on understanding advanced study for student of ninth gradersat Junior High School ofDarul Hamidin Padamara in the school year 2018/2019. This study used a sample of 30 students with the control class of 15 students and the experimental class of 15 students. The instrument used to know the comprehension of students' advanced studywas a set of 30 items. While the hypothesis testing technique used was the statistical analysis test ttest.Based on the result of data analysis, the data obtained from the pre-test measurement for the control class was 657 with the average of 43.8 and the post-test measurement data was 598 with the average of 39.9 or pre-test <post-test (657 < 598) and measurement data for the experimental class 1332> 971. With t-count 9.6 and t-table 2.048 so t-count is greater than t-table then Ha is accepted and Ho is rejected. So the hypothesis states that "The Effectiveness of the Implementation of Group Guidance Service in Increasing the Comprehension of the Advanced Study for student of ninth gradersat Junior High School of Darul Hamidin Padamarain the school year 2018/2019". It can be accepted. From this study, it can be concluded that the provision of group guidance service can have the positive impact on learning outcome for student of ninth gradersatjunior High school of Darul Hamidin Padamara.

### 3 Results and Discussion

Based on the result of study above, experimental study with the provision of group guidance service with technique of Peer Group was effective in improving the comprehension of advanced studyfor student of ninth graders atJunior High School ofDarul Hamidin Padamarain the School Year 2018/2019. Because the result obtained were very significant after being given treatment in the form of group guidance service with technique of peer group.

Where after the data collection before the treatment pre-test was obtained, the total score achieved by 15 students for the control class 598 with the average score of 39.9, in detail, from 15 students there were 15 students (100%) in the low category, (0 %) in the moderate category and (0%) in the low category, and for the experimental class the number of scores achieved by 15 students is 657 with an average score of 43.8, in detail, out of 15 students there are 15 students (100%) in low category (0%) in the medium category and (0%) in the low category. However, after being given treatment in the form of Guidance Service, the post-test group in the experimental class showed that the score achieved by 15 students was 1332 with an average score of 88., 8, in detail, from 15 students there (0%) for the high category, 15 (100%) for the medium category, while the post test questionnaire results for the class used as the control class showed that the score achieved by 15 students was 971 with the score on average average 64.73, in detail, from 15 students there (0%) for the high category, 2 (13%)

for the medium category, and 13 (87%) for the low category. This shows that there is an increase in the control and experimental groups as seen in some students who have an understanding of further studies with a low category on the pre-test results increasing into the moderate category in the post-test results as well as the experimental group experiencing a significant increase from the low category towards the medium category.

Based on the description described above, addressing the proposed hypothesis is stated as accepted. This shows that "the effectiveness of the implementation of group guidance service in improving the comprehension of advanced studyfor students of ninth graders at junior high school of Darul Hamidin Padamarain the school year 2018/2019 can provide meaningful contribution to student. According to Prayitno (1995: 62) stated that group guidance means utilizing the dynamic to achieve the goal of guidance and counseling. The group guidance is an effort to guide individual through group.

#### 4 Conclusion

Through experimental studywhich had been done as one of efforts to decide the effectiveness of the implementation of group guidance service in improving the comprehension of advanced studyfor student of ninth graders at Junior High School of Darul Hamidin Padamarain the school year 2018/2019. It can be concluded that the result of the questionnaire analysis before the treatment pre-test were obtained, the number of scores achieved by 15 students for the control class 598 with an average score of 39.9, and for the experimental class the number of scores achieved by 15 students was 657 with a score on average 43.8, but after being given treatment in the form of Guidance Services in the post-test group in the experimental class, it showed that the score achieved by 15 students was 1332 with an average score of 88.8, while the post-test questionnaire results in the class the control class showed that the score achieved by 15 students was 971 with an average score of 64.73. This shows that there wasenhancement in the control and experimental group as seen in some students who have an understanding of further studies in the low category on the pre-test results increasing into the moderate category post-test as well as the experimental group experiencing a significant enhancement from the low category to the category is being.
